I am a Case Manager at Another Case Management in Rockland and have been seeing Jane for the better part of two years. In that time, Jane was evicted from her home of 12 years, and has been sleeping in a pop-up camper on her mother's large property since September 15th of last year. I have seen this on many occasions, with the most recent being last week on Wednesday, April 28th.

She was forced to give up custody of her child due to her mental health and has been unable to find a suitable home. Her mother would love to provide a home for her, but she was awarded custody of her granddaughter, and Jane cannot be in contact with her, so she is unable to live in the home. They set up the old camper for her next to their old barn on the opposite side of the lot.

To help her out, her mother let her fix up their old pop-up camper and bought her a small space heater for the winter, which is powered from the house, but the condition of the shed is deteriorating and was never truly habitable. It leaks, has no running water, and the tarp barely keeps in the heat on really cold days.

I really hope that you can help Jane, as I fear that she may not last another winter in that camper.

I am a Case Manager at Somewhere Case Management in Portland, and I am writing to attest that I witnessed John Doe sleeping in a shed behind the local food pantry. The last time I saw him there was last Tuesday, December 13th.

The shed has a old cast—iron wood stove, which he also uses for cooking. He finds wood around the area in order to burn. The shed is owned by the pantry, and they have allowed him to live there for the last 6 months, but the city has begun to threaten them with fines if they allow it to continue. The roof leaks, it is un-insulated, and has a dirt floor. It is my opinion that this living situation is unsuitable, and I am looking to get him a voucher so that he can move into an actual residence.

I can attest that he has been living there for, at least, the last six months, with the last three times I have witnessed this being: 12/1/2023, 11/25/2023, 11/15/2023.

I am a Case Manager at Somewhere Case Management in Portland, and I am writing to attest that I witnessed John Doe sleeping in his car in the Walmart and Target parking lots for the last few months. I have seen him there on several occasions, with the most recent being 4/28/23, when he was arrested for harassment.

I saw him there with his belongings, including a pillow, blanket, hygiene items, and the car is filled with garbage. It is obvious that he sleeps there each night. While I have not witnessed him actually sleeping there, I have witnessed him dressing in the car the last morning I visited him as he was preparing for work as he walks at Walmart.

I have talked to his supervisor at Walmart and while she cannot provide written documentation, she did state that she knows that he is sleeping there and has had to advise him to find another location. She has also referred him to their staff assistance helpline several times.
