All instances of assistance are recorded and maintained in spreadsheets which track the spenddown of the funds and captures information regarding the client, who the funds will be paid to or what they will be used for, which program the request originated from, how it was paid (check, credit card, etc.) and the amount of the assistance. These spreadsheets are reconciled to the Finance Department's accounting software on a quarterly basis.
